- **APPLICABILITY**

(a) The topcoat and the basecoat have been applied on the entire vertical masonry surface in the

this warranty.

This warranty is applicable only if,

- (b) The volume of the topcoat purchased and used at a particular site is at least 20 litres. (c) 2-3 coats of the topcoat with minimum 20 litres of usage at a particular site is mandatory to avail
- (d) In any painting site, 1 coats of the basecoat is compulsory to avail this warranty.
- (f) Cracks up to 3 mm on the surface are filled with Berger Paints Crackfill Paste as per the application instructions provided in the product data sheet.

(e) The topcoat and basecoat are applied at a coverage rate specified in the product data sheet.

- (g) Water spouts are in accordance with the standard civil practices. (h) Walls should be free from water leakage or seepage.
- (i) No vertical surface, including but not limited to duct areas, is left uncoated due to inaccessibility.
- (j) Surface preparation and the application of the product has been done as per the instructions provided in the product data sheet.

(a) The warranty only provides for replacement cost of paint as per the reducing scale provided

CLAIMS

- Prior to such inspection, the customer shall not have the right to carry out any repair or remove any part of the paint. • The company's authorized personnel shall verify that all the products prescribed by the company
 - have been purchased in the required quantities and used as recommended by the company.

- This warranty is non-assignable and non-transferable. • In case of any dispute, the same is subject to exclusive jurisdiction of courts at Kolkata.
- · The section headings in this warranty are for convenience of interpretation only and do not have any legal or contractual effect.

All parties at all time will keep all matters and facts concerning any dispute, confidential.

- The customer must retain the original invoice(s) to avail this warranty. Upon receipt of a complaint, the company, at its discretion shall appoint/authorize a person who will visit the site for inspection and shall verify and confirm that the surface preparation and application of the product have been carried out as per the directions of the company. If require, it may carry out tests. The customer shall also retain the original invoice(s) raised by the dealer(s)/ contractor(s).
