DAMPSTOP DUO WARRANTY Berger Paints India Limited (referred to as "the Company") offers SEVEN (7) years warranty on its waterproofing product Dampstop Duo (the "Product"), solely for its application on exterior vertical surface (plastered, cementitious or puttied surface) as undercoat following recommended system specification.

1. If the total volume of Dampstop Duo purchased and used in a particular site exceeds 40 litres.

a) The Warranty shall apply only:

EXTENT AND APPLICABILITY OF WARRANTY

- 2. Dampstop Duo to be used only as undercoat on vertical exterior surface following recommended system application.
- 3. After application of Dampstop Duo, suitable Lewis Berger/Berger Paints topcoat (Weathercoat Long Life 10 / Weathercoat Long Life Flexo/ Weathercoat Long Life 7/ Weathercoat Anti Dustt / Weathercoat Champ/Weathercoat Glow) (henceforth referred to as "Top Coat") to be applied following suggested application process. Life of top coat should be more than 5 years as per the
- Company's warranty policy. 4. For individual site, where the consumption exceeds 40 litres, the warranty shall be applicable subject to a satisfactory pre-inspection of the exterior vertical surface to be coated with Dampstop
- Duo by the authorized representative of the Company. 5. The entire vertical surface along with the parapet walls shall be required to be coated, as per the
- 6. It is specifically agreed that only the surface that has been coated with Dampstop Duo shall be covered under this warranty. The warranty shall not cover problems or issues caused due to
- moisture/water seepage from surfaces not coated with Dampstop Duo. 7. Request for registration of the warranty has to be made by the customer to the Company or to
- the Company's authorize dealer within seven (7) days from the date of material purchase. The original copy of the invoice(s) has to be retained by the customer and to be produced to the representative of the Company on demand. Dampstop Duo has to be purchased either directly from the Company or from its dealers.
- 8. The Company's authorized representative will visit the customer's site for an inspection within reasonable time from the registration date.
- 9. Where any claim arises during the warranty period, the period will not start afresh after settlement
- of the claim.
- 10. Company under this Warranty is limited only to Coating Failure. The Company shall not be liable in case of any defects arising out of workmanship.
- 11. Any extra cost shall be borne by the customer and the Company shall in no way be liable and held responsible for the same.
- c) The words "Coating Failure" shall mean any of the following occurring, subject to the other conditions of this Warranty:
- 1. Failure of Exterior Positive Waterproofing caused due to water ingress through the coatings on the
- surface. 2. Film integrity, flaking and peeling of Dampstop Duo, caused by one coat of Dampstop Duo coming off from another or Dampstop Duo film coming off from the substrate, due to failure in exterior

c) Replacement of material shall mean the product only required to set right the area where paint failure has occurred, at the time of the lodgment of claim. Replacement shall not include cement, sand, polymer, paint system and labour cost. The Customer will be liable for the balance costs, which are not Company's obligations, as indicated above.

d) The Company will not be liable for any other indirect or consequential loss or damage to the customer or to any other person. The customer's exclusive and sole remedy under this Warranty shall

c) Water leakage or seepage in the walls through exterior sources such as broken water pipes, damaged sewerage lines, water leakage from toilets and kitchens due to faulty or rusted pipelines, damage in concrete or brickwork, dripping of water or water leakage from any source including but not limited to vegetation, air-conditioning units and plant pots, water leakage, seepage and continuous

- If severe damages are observed to the soffits, then it is recommended that an inspection is carried out by a competent Structural Consultant All loose dust, dirt, grease, moss, fungus etc. has been removed mechanically from the surface,
- Apply second coat of Dampstop Duo with 100% dilution. Allow second coat to dry for 6-8 hours

 Apply suitable top coat (having minimum 5 years life warranty. Minimum 2 coats of the top coat to be applied following recommended application process and to check that there is no void surface

All corners, gaps, joints, protrusions & outlets to be coated with two extra coats of Dampstop Duo,

NOTE: Single coat application of Home Shield Dampstop Duo will also be considered for warranty. For the same, dilution ratio of Dampstop Duo must not exceed 50%, but the other terms and conditions

• Protect the Dampstop Duo coating with a polythene/Tarpaulin sheet if it is expected to rain within 72 hours after application of the 2nd coat. Notwithstanding anything to the contrary stated herein,
